Installation LEOSA & State Concealed Carry Permit Information

At the discretion of the installation commander, LEOSA and Wyoming Concealed Firearm Permit credentialed personnel are authorized to transport privately owned firearms (POF) in privately owned vehicles (POV) while on the installation. This authorization DOES NOT allow for the concealed carry or open carry of ANY POF into **ANY facility**** within the established legal boundary of F. E. Warren AFB. The only exception is privatized housing and 90 SFG Armory for storage purposes only. Individuals MUST have a valid LEOSA, WCFP, or RCCL credentials immediately available at all times when they have a LOADED firearm in their POV while on F. E. Warren AFB. Personnel who are NOT in physical possession of, or who HAVE NOT been issued, an authorized LEOSA, WCFP, or RCCL credential are NOT permitted to transport LOADED POFs under the parameters of this authorization. Individuals are required to maintain their LEOSA credentials, WCFP or RCCL on their person at all times and must surrender it along with valid DoD identification card when requested by Security Forces, OSI or local law enforcement officials. The installation commander or Defense Force Commander (DFC) may suspend POF transport authorization on the installation based upon increased FPCON or local threat at any time.

POFs are NOT authorized in ANY facility or ANY Restricted/Controlled Area within the established legal boundary of F. E. Warren AFB.

****NOTE:** The only exceptions to the “ANY facility” reference throughout this pamphlet are privatized housing and 90 SFG Armory for storage purposes only**

What is LEOSA?

The Law Enforcement Officer Safety Act (LEOSA) of 2004 is a federal law that allows Qualified Law Enforcement Officers (QLEO) and Qualified Retired Law Enforcement Officers (QRLEO) to carry a concealed firearm in any jurisdiction in the United States, regardless of state or local laws, with certain exceptions. In accordance with the law, QLEOs and QRLEOs can carry concealed privately owned weapons (POF) for protection. LEOSA credentials do not grant the bearer any authority to act on the USAF's behalf or to exercise any law enforcement authority, when off duty.



Who is Issued a LEOSA Credential?

Qualified Police or Law Enforcement Officer. Individuals granted apprehension authority under Article 7b of the Uniform Code of Military Justice (UCMJ) must meet the definition of qualified police or law enforcement officer requirements defined in DoDI 5525.12, Enclosure 3, in order to be issued a credential under LEOSA (active duty, separated and retired). For additional information refer to AFMAN 31-125.

Wyoming Concealed Firearm Permit

Wyoming Concealed Firearm Permit, IAW Wyoming State Statute Chapter 8, Section 6-8-104, Subsection (b), or holders of reciprocating state concealed carry licenses (CCL) equivalents are authorized to transport and secure POFs in POVs within the legal boundary of F. E. Warren AFB. This DOES NOT authorize the concealed carry or open carry of POFs into ANY facility on F. E. Warren AFB.

What States have reciprocity with Wyoming?

Alabama, Alaska, Arizona, Arkansas, Colorado, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Michigan, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Mexico, North Carolina, North Dakota, Ohio, Oklahoma, Pennsylvania, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia, West Virginia, and Wisconsin.



Who is Not Authorized?

Private contractors, visitors, and/or holders of special/unique/one-time passes WILL NOT be allowed to bring handguns into the established legal boundary of F. E. Warren AFB.

Transportation of POFs

Properly credentialed personnel are authorized to transport POFs in POVs in the LOADED configuration while on the installation. Individuals WILL secure handguns in an appropriate weapons case or vehicle compartment of POV when left unattended and maintain positive control of keys at all times. Additionally, credentialed personnel WILL NOT remove handguns from POV at ANY time (Exception: privatized housing and 90 SFG Armory for storage purposes only). Credentialed personnel WILL NOT be allowed to store/secure a handgun in an unattended vehicle for more than 18 hours.

What Type of Firearm is Authorized to Carry?

Type of firearm is defined as: handgun (as defined in the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) Publication, Federal Firearms Regulations Reference Guide, The term "handgun" means a firearm which has a short stock and is designed to be held and fired by the use of a single hand. The term "firearm" does not include any machine gun as defined in the National Firearms Act, any firearm silencer, or any destructive device as defined in section 921 of Title 18.

Off Limit Areas

POFs are NOT authorized in ANY facility or ANY Restricted/Controlled Area within the established legal boundary of F. E. Warren AFB. Credentialed individuals residing in or visiting F. E. Warren AFB dormitories, lodging, or Temporary Living Facilities (to include D. A. Russell Family Campground) WILL NOT be allowed to store/secure a handgun/weapon of any type inside a dormitory room, lodging room, TLF Facility, camper or vehicle at ANY time (to include QLEO's). Additionally, if POF is being transported, POV is not authorized to be in the vicinity of ANY dormitory parking areas. All POFs owned by dormitory residents WILL be registered, secured, and stored in the 90 SFG Armory prior to parking in the vicinity of ANY dormitory on the installation.

Acceptable Storage Area

Credentialed Airmen that reside in F. E. Warren AFB dormitories WILL NOT temporarily store firearms in their POVs; firearms MUST be stored in 90 SFG Armory. Credentialed personnel residing in privatized housing may store their firearms in their residences or 90 SFG Armory. Personnel storing POFs in on-base housing (government or privatized quarters) will be required to register weapons with the 90 SFS Reports and Analysis section no later than ten (10) duty days from the date of acquisition or moving into base housing.

When firearms are temporarily stored in a vehicle:

The vehicle MUST be locked at all times when unattended. The firearm MUST be stored in a closed compartment (i.e. glove box, center console), or placed under the seat in an area that is not visible from the outside of the vehicle. Credentialed personnel WILL NOT be allowed to store/secure a handgun in an unattended vehicle for more than 18 hours.

Sobriety

Credentialed personnel SHALL NOT transport a firearm while under the influence of alcohol (BrAC/BAC of .02 or greater) or another intoxicating or hallucinatory drug or substance.

Contact with Law Enforcement or Command Officials

Credentialed individuals stopped for base entry point checks, traffic violations, or for any other reason by law enforcement or command officials (Commanders & First Sergeants):

- ◆ All credentialed personnel MUST immediately inform law enforcement or command officials that there is a firearm in the vehicle or on their person.
- ◆ LEOSA credentialed personnel MUST be able to produce their LEOSA credentials and proof of training.
- ◆ All credentialed personnel may be apprehended/detained for failure to inform law enforcement or command officials that they are carrying/transporting a concealed weapon.
- ◆ All credentialed personnel may have their privately owned weapon temporarily confiscated until they can produce proper credentials.
- ◆ All credentialed personnel may have their authorization to transport privately owned weapons in privately owned vehicles while on the installation suspended or revoked.

Suspension of Transportation Authorization

Individuals who violate any of the procedures above may lose their privilege to transport concealed POFs on the installation or to store their weapons in their vehicle while on base. Suspension periods:

- ◆ First offense: 30 day suspension of concealed transport authorization.
 - ◆ Second offense: 6 month suspension of concealed transport authorization.
 - ◆ Third offense: Permanent revocation of concealed transport authorization.
- Suspension Appeals. Request to appeal suspensions of LEOSA or concealed carry authority must be submitted in writing to the 90 MW/CC through 90th Security Forces Squadron, Reports and Analysis.
